REQUIRED DOCUMENTS

- ◆ Birth Certificate
- ◆ Medical Health Certificate
- ◆ Police certificate
- ◆ Letter of recommendation from the head of the School/University for children between 12 and 18 years old
- ◆ Proof of payment of relevant fees
- ◆ Affidavit of Source of Funds
- ◆ Detailed Business Background Reports/Resume
- ◆ Letter of Employment/ Financial Statements
- ◆ Recommendation from applicant's bankers
- ◆ Two (2) personal and professional references
- ◆ Passport size photos for each applicant
- ◆ Marriage Certificate/Dissolution of Marriage if required
- ◆ Notarized copies of University/College Diplomas
- ◆ If documents are not in English, both original and translated ones must be given

STEPS AND PROCEDURES

- ◆ Client prescreening for eligibility
- ◆ Client signs letter of engagement and pays down payment on professional fees
- ◆ Collection and attestation of required documents
- ◆ Client pays balance on professional fees.
- ◆ Submission of client's application
- ◆ Due diligence check
- ◆ Payment of government donation or real estate investment amount
- ◆ Issuance of certificate of naturalization and passport

The St. Kitts and Nevis Economic Citizenship Programme was established in 1984, making this second passport program the longest established scheme of its kind in the world.
