REQUIRED DOCUMENTS

- ◆ Current passport
- ◆ Medical certificate
- ◆ Birth Certificate
- ◆ Proof of clean criminal record
- ◆ Proof of payment of relevant fees
- ◆ Marriage Certificate/Dissolution of Marriage
- ◆ Affidavit of Source of Funds
- ◆ Academic documents

STEPS AND PROCEDURES

- ◆ Client prescreening for eligibility
- ◆ Client signs letter of engagement and pays down payment on professional fees
- ◆ Collection and attestation of required documents
- ◆ Client pays balance on professional fees. Submission of client's application
- ◆ Due diligence check on applicant and family members over 16years
- ◆ Payment of investment amount
- ◆ Issuance of certificate of naturalization and passport

LEGAL BASIS

The Citizenship by Investment (CBI) program is protected by Grenada's legislation, namely the “Citizenship by Investment Act 15, 2013.” This law is documented and published and forms part of the laws of Grenada as framed and approved by the national parliament
